**Intended Service:**

Salt and fresh water ballast, bilge, sanitary, cargo oil, fuel oil, lubricating oil, compressed air.

**Description:**

MSJ/57 Wafer type steel valves with centric disc and bonded liner in the range 50 mm to 600 mm.

MSJ Wafer type steel valves with centric disc and bonded liner in the range 550 mm to 1200 mm.

**Ratings:**

PN10, PN16 & ANSI class 150 lb, PN20.

**Service Restrictions:**

1. Wafer and unthreaded lug type valves are not to be used for any connections to the vessel's shell.
2. Valve materials to be suitable for the fluid service.
3. Not for use in fire mains.
4. Unit Certification is not required for this product. If the manufacturer or purchaser request an ABS Certificate for compliance with a specification or standard, the specification or standard, including inspection standards and tolerances, must be clearly defined.

**Comments:**

1. All valves are to be hydrostatically tested by the Manufacturer and are to bear the trademark of the Manufacturer legibly stamped or cast on the exterior of the valves as well as the primary pressure rating.
2. Valves intended for installation on the side shell or below the deepest load waterline, including those at sea chests, are to be hydrostatically tested in the presence of the Surveyor, before installation, to a pressure of at least 5 bar.g.
3. The connection arrangements for shell valves are to ensure that the valve remains in position should the piping inboard side be removed.
4. Applications other than those listed above are subject to individual approval.
